Opening Remarks- by Mr. Zegiestowsky:

 Mr. Zegiestowsky took roll for the meeting that was held on TEAMS. An Executive Session meeting will immediately follow this meeting.

November 2022, Board Minutes Approval-by Mr. Zegiestowsky:

• Mr. Zegiestowsky asked for Board members to review the minutes sent out to see if they had any edits or questions.

Ms. Kinzer motioned for the approval of the minutes and Mr. Slabach seconded the motion. There were no objections or abstentions, and the motion was passed unanimously.

Mr. Zegiestowsky then moved the agenda forward to discuss the RHRCA Audit Summary.

Ms. Adornato motioned to approve; Mr. Doug Doyle seconded the motion. There was no oppositions or abstentions. The budget and use of funds was approved unanimously.

• Mr. Zegiestowsky then turned the agenda to the RHRCA Appointment of Secretary with the recommendation that the Executive Director would formally assume this role.

Mr. Lewis motioned for approval for Delegation to the Executive Director to serve as Secretary of the RHRCA Board. Mr. Doyle second motion for approval. No oppositions, abstentions. It was passed unanimously.
