Executive Summary

The Pennsylvania Asthma Control Program (ACP) is funded by the Centers for Disease Control and Prevention (CDC). The goal of the ACP is to improve the quality of life for those living with asthma. The ACP is implementing strategies shown to work in areas with high asthma rates, while also strengthening leadership, partnerships, and communications needed for long-term improvement of asthma control and management. Over time, these actions will reduce the number of deaths, hospitalizations, emergency department visits, school days or workdays missed, and limitations on activity due to asthma. A critical component of the ACP is the Pennsylvania Asthma Partnership (PAP). The PAP was re-convened in January 2021 and is a mixture of Department of Health staff and partners representing 21 organizations invested in helping those with asthma achieve their best health. The PAP developed a new Asthma Strategic Plan for 2021-2026 to act collectively to address the impact of asthma.

Part of the ACP's work is to gather information from a variety of sources on all aspects of asthma in Pennsylvania such as how many people have asthma, if asthma is resulting in emergency department visits or hospitalizations, if different groups are reporting more asthma than other groups, the availability and use of different programs and services to control asthma, environmental exposures, housing and neighborhood conditions, and the impacts of discriminatory practices and policies. Not only is it important for this information to be gathered, but it must also be shared. This aligns with a strategic plan objective specific to the production of asthma data reports.

This report contains information on asthma trends by county as reported to Pennsylvania school districts. Additionally, as recommended by the PAP, this report contains additional information about each county to provide some context for the asthma information. The information in the tables throughout this report was selected by the PAP to be helpful for those using the report and includes county demographics, other county asthma-related information, environmental exposures, and youth smoking and vaping percentages. The intended audience for this report is organizations working with or providing services to those with asthma, county health departments, public health professionals, health care professionals, or anyone wanting to know more about asthma in a specific county to educate, advocate, or apply for funding opportunities.

Methods

Information for the report was accessed from the following sources:

Pennsylvania Health Care Cost Containment Council (PHC4): The age-adjusted asthma hospitalization rate was retrived from the Department of Health's <u>Enterprise Data Dissemination Informatics Exchange</u> (EDDIE). The primary source of the hospitalization information is the PHC4. Hospital discharge counts reflect acute hospital visits by county of residence. Patients can be counted more than once if they are discharged from a hospital, for the same diagnosis, procedure, or condition during the same year. The three-year time frame was used to provide a rate for as many counties as possible. A notation of "ND" means "not displayed" as the count of hospitalizations was less than 20 for the county.¹ County rates above the state rate are indicated with an asterisk (*).

Pennsylvania Department of Health, Division of School Health: Public school entities are required to submit an annual report to the Division of School Health which includes aggregate totals for select chronic conditions with medication administered, screenings, exams, injuries, and staffing.² The following information was retrieved from the Division of School Health:³

- Percentage of students with asthma by county.
- Number of nurses and supplemental staff per 10,000 students by county. Supplemental staff are defined as registered nurses, licensed practical nurses, or unlicensed personnel supplemental to the certified school nurse.

Pennsylvania Department of Health, Environmental Health Indicators (EHI) Map: The EHI map displays environmental health indicators and relevant risk factors, particularly for populations at higher risk for poor health outcomes. The map compiles information from the Department of Health, the Department of Environmental Protection and several fedeal agencies to provide context about environmental hazards and social and health information. The following information was retrieved from the EHI map using the "sort by" feature: 5

- Number of conventional oil and gas wells by county.
- Number of unconventional oil and gas wells by county.

County Health Rankings & Roadmaps: The <u>County Health Rankings & Roadmaps</u> program provides data, evidence, guidance, and examples to build awareness of the multiple factors that influence health and are unique in the ability to measure the health of nearly every county in all 50 states.⁶ An "N/A" indicates the data were not available. The following information was retrieved from the 2023 County Health Rankings & Roadmaps:⁷

- Percentage of population below 18 years of age.
- Percentage of children under 18 years of age in poverty.
- Percentage of population that is not proficient in English.
- Percentage of population living in a rural area.
- Percentage of the population who is uninsured.
- Ratio of population to primary care physicians.
- Percentage of population self-identifying as non-Hispanic White.
- Percentage of population self-identifying as non-Hispanic Black or African American.
- Percentage of population self-identifying as American Indian or Alaska Native.

- Percentage of population self-identifying as Asian.
- Percentage of population self-identifying as Native Hawaiian or Other Pacific Islander.
- Percentage of population self-identifying as Hispanic.
- Average daily density of fine particulate matter in micrograms per cubic meter (PM2.5).

American Lung Association (ALA): ALA trains facilitators to implement the asthma self-management education programs Open Airways for Schools (OAS) and Kickin' Asthma (KA). Trained facilitators have active certifications for three years and only 11 counties currently have trained facilitators. The following information was retrieved from ALA administrative records in April 2023:⁸

Number of trained OAS or KA facilitators by county.


Youth Risk Behavioral Surveillance System (YRBSS): The YRBSS is a set of surveys that track behaviors that can lead to poor health in middle school and high school students. The surveys are administered every other year and are available only at the state level. ⁹ The following information was retrieved from YRBSS: ¹⁰

- Percentage of high school students currently smoking cigarettes.
- Percentage of high school students currently using electronic vapor products.
- Percentage of middle school students currently smoking cigarettes.
- Percentage of middle school students currently using electronic vapor products.¹¹

Findings

Map 1 shows a statewide comparison of the percentage of students with asthma and the number of nurses and supplemental staff per 10,000 students by county for the 2020-2021 school year. The percentage of students with asthma ranged from 4.6% in Montour County to 17.3% in Philadelphia County. The number of nurses and supplemntal staff ranged from 12.3 per 10,000 students in Dauphin County to 53.9 per 10,000 students in Forest County. On the following pages, trend lines for the percentage of students with asthma and additional data are provided for each county. The purpose of the additional data is to provide some information on the county environment where students with asthma are living, learning, working, and playing.

State Overview:

- For 2019-2021, the age-adjusted asthma hospitalization rate for Pennsylvania was **50.8** hospitalizations per 100,000 people. The hospitalization rate ranged from **17.0** hospitalizations per 100,000 people in Lycoming County to **269.9** hospitalizations per 100,000 people in Philadelphia County.
- The number of conventional oil and gas wells ranged from zero wells in twelve counties to 35,754 wells in McKean County.
- The number of unconventional oil and gas wells ranged from **zero** wells in 27 counties to **3,575** wells in Bradford County.
- The percentage of the population below 18 years of age ranged from **4.6%** in Forest County to **23.3%** in Lancaster County and was **20.6%** for Pennsylvania.
- The percentage of children under 18 years of age living in poverty ranged from 7.8% in Montgomery and Chester Counties to 34.8% in Forest County and was 16.3% for Pennsylvania.
- The percentage of the population that is not proficient in English ranged from **0**% in Cameron County to **6.0**% in Philadelphia County and was **2.1**% for Pennsylvania.
- The percentage of the population living in a rural area ranged from **0**% in Philadelphia County to **100**% in Forest, Fulton, Potter, and Sullivan Counties and was **21.3**% for Pennsylvania.
- The percentage of the population who are uninsured ranged from **5.0%** in Montgomery County to **14.0%** in Lancaster County and was **7.7%** for Pennsylvania.
- The ratio of population to primary care physicians ranged from **173:1** in Montour County to **6,155:1** in Juniata County and was **1,216:1** for Pennsylvania.
- The percentage of the population self-identifying as non-Hispanic White ranged from **33.7%** in Philadelphia County to **97.1%** in Elk County and was **74.8%** for Pennsylvania.
- The percentage of the population self-identifying as non-Hispanic Black or African American ranged from **0.5%** in Elk, Jefferson, Potter, and Warren Counties to **40.2%** in Philadelphia County and was **10.9%** for Pennsylvania.
- The percentage of the population self-identifying as American Indian or Alaska Native ranged from **0.2**% in 23 counties to **1.1**% in Lehigh County and was **0.4**% for Pennsylvania.
- The percentage of the population self-identifying as Asian ranged from **0.2%** in Forest and Fulton Counties to **8.4%** in Montgomery County and was **3.9%** for Pennsylvania.

- The percentage of the population self-identifying as Native Hawaiian or Other Pacific Islander ranged from 0% in 33 counties to 0.2% in Berks, Fayette, Lehigh, Monroe, and Philadelphia Counties and was 0.1% for Pennsylvania.
- The percentage of the population self-identifying as Hispanic ranged from **0.8%** in Armstrong and Elk Counties to **28.0%** in Lehigh County and was **8.4%** for Pennsylvania.
- The average daily density of fine particulate matter in micrograms per cubic meter (PM2.5) ranged from 5.5 micrograms per cubic meter in Tioga County to 14.1 micrograms per cubic meter in Allegheny County and was 8.5 micrograms per cubic meter for Pennsylvania.
- Of the 11 counties with trained ALA facilitators, the number trained ranged from **one** in five counties to **19** in Allegheny County.

Figure 1: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Adams County



Figure 2: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Allegheny County



Figure 3: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Armstrong County



Figure 4: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Beaver County



Figure 5: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Bedford County



Figure 6: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Berks County



Figure 7: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Blair County



Figure 8: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Bradford County



Figure 9: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Bucks County



Figure 10: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Butler County



Figure 11: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Cambria County



Figure 12: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Cameron County



Figure 13: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Carbon County



Figure 14: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Centre County





Figure 16: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and Clarion County



Figure 17: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Clearfield County



Figure 18: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Clinton County



Figure 19: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Columbia County



Figure 20: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Crawford County



Figure 21: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Cumberland County



Figure 22: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Dauphin County



Figure 23: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Delaware County



Figure 24: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Elk County



Figure 25: Percent of Studnets with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Erie County



Figure 26: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Fayette County



Figure 27: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Forest County



Figure 28: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Franklin County



Figure 29: Percent of Students with Medical Diagnosis of Asthma by School Year in Pennsylvania and in Fulton County



Figure 30: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Greene County



Figure 31: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Huntingdon County



Figure 32: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Indiana County



Figure 33: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Jefferson County



Figure 34: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Juniata County



Figure 35: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Lackawanna County



Figure 36: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Lancaster County



Figure 37: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Lawrence County



Figure 38: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Lebanon County



Figure 39: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Lehigh County



Figure 40: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Luzerne County



Figure 41: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Lycoming County



Figure 42: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in McKean County



Figure 43: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Mercer County



Figure 44: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Mifflin County



Figure 45: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Monroe County



Figure 46: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Montgomery County



Figure 47: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Montour County



Figure 48: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Northampton County



Figure 49: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Northumberland County



Figure 50: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Perry County



Figure 51: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Philadelphia County



Figure 52: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Pike County



Figure 53: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Potter County



Figure 54: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Schuylkill County



Figure 55: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Snyder County



Figure 56: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Somerset County



Figure 57: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Sullivan County



Figure 58: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Susquehanna County



Figure 59: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Tioga County



Figure 60: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Union County



Figure 61: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Venango County



Figure 62: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Warren County



Figure 63: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Washington County



Figure 64: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Wayne County



Figure 65: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Westmoreland County



Figure 66: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in Wyoming County



Figure 67: Percent of Students with a Medical Diagnosis of Asthma by School Year in Pennsylvania and in York County


