SPEAKER BIOGRAPHIES



DEBRA L. BOGEN, MD, FAAP Pennsylvania Acting Secretary of Health

Prior to joining the Commonwealth, Dr. Bogen was the Director of the Allegheny County Health Department, where she and her staff stayed on top of the pandemic and provided consistent, measured and commonsense information to the public while working closely with many stakeholders in the county. Prior to that appointment, Dr. Bogen was a member of the Pittsburgh region medical and research community for more than two decades. She held a primary academic appointment as

Professor of Pediatrics at the University of Pittsburgh, and secondary appointments in psychiatry and clinical and translational science. Dr. Bogen also served as the Vice Chair of Education for the Department of Pediatrics at UPMC Children's Hospital of Pittsburgh. She dedicated her career as a pediatrician to caring for children and families impacted by social inequities. Her clinical research focused on the impact of mental health and substance use on families. Dr. Bogen earned her medical degree from the University of Colorado School of Medicine and completed both her pediatric residency and general academic pediatrics fellowship at Johns Hopkins Hospital. She was one of the founders of the Mid-Atlantic Mothers' Milk Bank and served as the organization's Volunteer Medical Director until assuming her role at the state

BELINDA OSTROWSKY, MD, MPH Field Medical Officer, Division of Healthcare Quality **Promotion, CDC/New York**

Belinda Ostrowsky is currently a Field Medical Officer at CDC, Division of Healthcare Quality Promotion in NY. She works closely with New York State DOH and other public health facility and professional groups on healthcare-associated infections, antimicrobial resistance and antimicrobial stewardship program topics, including C. auris and MDROs. She formerly was the Director of Epidemiology, Stewardship, and Infection Prevention



at Montefiore/ Einstein, Bronx NY and remains a Clinical-Associate Professor. She is a fellow of the Infectious Disease Society of America and the Society for Healthcare Epidemiology of America, and a Chairperson for ID week 2023.

MEGHAN LYMAN, MD Medical Officer, Mycotic Diseases Branch, CDC



Meghan Lyman is a Medical Officer in CDC's Mycotic Diseases Branch, focusing on Candida, including Candida auris, and antifungal resistance. She completed medical school and an Internal Medicine Residency at Emory University in Atlanta, GA. She then joined CDC as an Epidemic Intelligence Service Officer in the Division of Healthcare Quality Promotion, after which she joined the International Infection Control Program.

LINDA BEHAN, BSN, RN, CIC Consultant, Long Term Care Infection Prevention, LLC

Linda Behan is currently an IP consultant and President of Long Term Care Infection Prevention, LLC. She has been certified in infection prevention and control since 2011. Linda has presented at Association for Professionals in Infection Control and Epidemiology's (APIC) annual conferences on antibiotic stewardship, enhanced barrier precautions to control multidrug resistant organisms, and infection surveillance. She is a presenter on infection prevention and control topics for healthcare and other professional organizations. She served on the APIC LTC Task Force and was a subject matter expert for the development of the APIC LTC-CIP certification preparation course.


