Be sure that your doctor gets all of the test results for your baby!

If your baby does not pass the screening in one or both ears, or was not screened, ask your doctor about an outpatient screening for your baby.

If your baby does not pass the screening in one or both ears, the screening provider should refer your baby for CMV screening. CMV screening should be performed within 21 days of birth.

Most children with hearing loss are born to parents who have normal hearing.

Some babies are born with normal hearing but lose their hearing when they are older.

Schedule a checkup with your health care provider when your baby is 2 to 4 days old.

If your baby did not pass an outpatient or final screening, ask your doctor to schedule an appointment with a pediatric audiologist as soon as possible.

Children as young as 1 month of age can be fitted with hearing aids.

If your baby has a hearing loss, the next steps are:

- ✓ Enroll in early intervention by calling the CONNECT Line at 1-800-692-7288.
- ✓ Enroll in the Family Connections for Language and Learning program by calling 717-580-0839.
- ✓ Learn about communication options.
- Discuss the use of hearing aids and FM systems with your audiologist.
- ✓ Be sure that your doctor has the audiology test results.

Before 6 Months of Age

Other visits and testing can include:

- ✓ Seeing a pediatric ophthalmologist (eye doctor); an ears, nose and throat (ENT) doctor and a geneticist;
- ✓ Regular visits with your audiologist; and
