I. Executive Summary

The 2021 Pennsylvania's Dentist and Dental Hygienist Workforce report presents findings from the 2021 Dentist Survey and 2021 Dental Hygienist Survey. These surveys were designed to collect information on the characteristics and distribution of the dentist and dental hygienist workforces within the commonwealth.

The surveys were conducted in conjunction with the biennial license renewal for dentists and dental hygienists. It is important to note that dentists and dental hygienists receiving their first license were not included in the survey.

Dentists

In 2021, 9,174 dentists renewed their license and responded to the dentist survey. Data were available for analysis for 9,127 dentists. Of these 9,127 dentists, 8,456 (92.6%) were employed in dentistry. Among these 8,456 dentists, 7,869 (93.1%) provided direct patient care in Pennsylvania.

The average age of dentist respondents was 52 years. The majority of dentists (65.7%) were males and 31.3% were females. Dentist self-identified race was 69.9% White, 14.2% Asian, and 2.6% Black. Most dentists identified as non-Hispanic (97.8%). Among licensed dentists, 82.7% lived in Pennsylvania and 8.2% lived in neighboring states.

In 2021, 26.4% of respondents who provided direct patient care in Pennsylvania practiced in a dental specialty. The most common specialties were orthodontics (25.2%), oral surgery (23.4%), pediatric dentistry (19.2%), endodontics (12.1%), periodontics (11.2%), prosthodontics (6.2%), and anesthesiology (2.1%).

In 2021, 20.2% of dentists provided direct patient care in rural counties in Pennsylvania. The rate of dentists providing direct patient care per 100,000 population was 40.7 in rural counties and 56.5 in urban counties in Pennsylvania in 2021.

Medicaid patients and Medicare patients were accepted by 26.7% and 34.5% of dentist respondents who provided direct patient care in Pennsylvania. New patients were accepted by 95.1% of dentist respondents in 2021. Of those who accepted new patients, 32% accepted Medicaid patients and 40% accepted Medicare patients.

In addition, 33.3% of dentist respondents who provided direct patient care in Pennsylvania planned to practice for 16 or more years and 16.3% for less than three years. The primary reason for young dentists (21 - 34 years of age) who provided direct patient care to leave in less than six years was due to family concerns. Retirement was the primary reason for older dentists (45 years of age or older) to leave in less than six years.

Dental Hygienists

In 2021, 7,530 (86.3%) were employed in dental hygiene. Of these respondents, 7,169 (95.2%) provided direct patient care in Pennsylvania.

Among respondents who provided direct patient care in the commonwealth: 1) 74% completed an associate degree in dental hygiene as their highest level of education and 6.6% were enrolled in a higher education program in dental hygiene, 2) 24% held their primary job in a rural county and the rate was 46.6 per 100,000

population in rural counties and 51.2 per 100,000 population in urban counties, 3) 19% were employed in more than one position and 90.2% were employed by private dental practices owned by partnerships and solo dentists, 4) 95.5% were satisfied or very satisfied with their primary job and 93.1% were satisfied or very satisfied with dental hygiene as a career, 5) 51% had practiced for 16 years or longer and 35% anticipated practicing for 16 years or longer, and 6) 43% planned to leave dental hygiene in less than six years and the reasons for leaving included were: retirement (42.0%), physical demands (16.2%), stress/burnout (14.5%), change careers (10.2%), family reasons (8.0%), completing further training (4.7%), financial reasons (2/7%), and relocation (1/3%).

II. Background

Dentists diagnose and treat conditions and diseases that are generally related to the oral cavity (mouth) and provide preventive health advice to patients. Dentists perform a variety of activities, such as applying dental varnishes to prevent cavities in children, removing tooth decay, filling cavities, repairing fractured teeth and bones of the jaw, reading x-rays, performing corrective surgery on gums and supporting bones to treat gum diseases, extracting teeth, and providing replacements for missing teeth. In addition, dentists may administer anesthetics and write medication prescriptions in conjunction with these activities.

Individuals studying to become dentists complete at least eight years of education following high school. In addition to completing a bachelor's degree, individuals must take the Dental Admission Test (DAT) before applying for admission to dental school. Upon graduation from an accredited dental school, a dentist receives a degree of either a Doctor of Dental Surgery (D.D.S.) or a Doctor of Dental Medicine (D.M.D.). Dentists may practice in general dentistry or may choose to undergo further training by completing a residency program in one of the specialty areas of dentistry that include orthodontics, oral and maxillofacial surgery, pediatric dentistry, periodontics, prosthodontics, endodontics, oral pathology, oral and maxillofacial radiology, or public health dentistry. Dental residencies require one to four years to complete, depending on the area of specialty.

In all 50 states, the District of Columbia, and territories, dentists must be licensed to practice dentistry. To obtain a license, dentists must graduate from an accredited dental school and pass a licensing clinical examination accepted by the state where they wish to practice. In Pennsylvania, the State Board of Dentistry (board) within the Department of State is responsible for regulating dental practice through licensure, registration, and certification of members of the dental professions. The board also licenses dental hygienists upon completing an approved dental hygiene education program and passing written and clinical examinations. Individuals who have completed a board-approved training program and passed a certification examination may become certified by the State Board of Dentistry as an expanded function dental assistant. Expanded function dental assistants may perform higher level procedures under the direct supervision of a dentist. General dental hygienists provide preventive dental care such as cleaning teeth and educating patients on good oral health practices.

A licensed dental hygienist may become certified by the State Board of Dentistry as a public health dental hygiene practitioner upon completion of 3,600 hours of practice under the supervision of a dentist and after securing appropriate professional liability insurance. Public health dental hygiene practitioners may provide dental hygiene services in certain public health settings without the supervision of a dentist.

III. Methods And Technical Notes

Dentists and dental hygienists renew their Pennsylvania license to practice every two years through the Department of State, Bureau of Professional and Occupational Affairs (BPOA). In cooperation with the BPOA, the Department of Health's Primary Care Office surveys dentists and dental hygienists renewing their licenses. The surveys are designed to collect information on the characteristics and distribution of the dentist and dental hygienist workforces in the commonwealth.

In 2021, dentists and dental hygienists licensed under the State Board of Dentistry were surveyed during the license renewal period. The surveys were conducted online. Because these surveys are tied to the licensure renewal process, the data captured does not include first-time licensees or most individuals in training. Surveys without a valid license number and surveys with inactive or expired license numbers were removed. Data analysis was conducted on valid surveys returned by both dentists and dental hygienists.

The information presented in this report, unless noted, is based upon actual response counts. Participants may choose to answer or skip a question and thus the extent of non-response (missing) data varies. Non-response bias results when respondents differ in meaningful ways from non-respondents. It can affect how well the response data represents the population being surveyed. For these reasons, caution should be exercised when interpreting the response data and descriptive findings presented in this report. The survey questions used for both dentists and dental hygienists have changed over the different survey years, resulting in some differences in the data collected.

IV. Dentists Licensed in PA Responding to the 2021 Dentist Survey


Age and Sex

In 2021, 9,174 dentists renewed their licenses and responded to the dentist survey. Data were available for analysis for 9,127 dentists. The average age of dentist respondents was 52 years. Table 1 lists the distribution of dentist respondents by age group and sex in 2021. The majority of dentists identified as male (67.3%) than female dentists (32.7%) and 40 (0.4%) identified as other gender. Among male respondents, there were more dentists in the older age groups than in the younger age groups. Approximately two thirds of male dentists who responded were aged 50 years or older, and close to one third of male dentists were aged 65 years or older. Among female respondents, there were more dentists in the younger age groups than in the older age groups. Only one third of female dentists were aged 50 years or older. By age group, the gender difference became larger among older age groups, as shown in Figure 1. Of note, the expected age upon dental graduation was around 25 years and the survey was not conducted until the renewal of the dental license, which might be the reason that there were fewer dentists in the age group of 21-29 years.

Race and Ethnicity

The distribution of respondents by race and ethnicity is listed in Table 2. Majority of dentists self-identified ethnicity were non-Hispanic Whites (69.9%), followed by non-Hispanic Asians (14.2%). Non-Hispanic Black and Hispanic dentists comprised 2.6% and 2.2% of total dentists, respectively, while American Indians/Alaska Natives and Native Hawaiians/other Pacific Islanders comprised 0.2% of total dentists, respectively.



Residence

Figure 2 presents the state of residence for dentist respondents. In 2021, 82.7% of dentist respondents resided in Pennsylvania, followed by 5.5% in New Jersey, 1.6% in Florida, 1.5% in Maryland, and 1.2% in New York. In addition, 7.2% resided in other states or territories, and 0.3% resided outside the US, meaning that they resided in those areas but maintained a dental license in Pennsylvania.

Figure 2. Respondents Licensed in Pennsylvania by State of Residence, 2021 Dentist Survey




Dental Education

Figure 3 displays the states from which dentist respondents graduated from a dental school. In 2021, 66.8% of respondents reported that they graduated from a dental school in Pennsylvania, followed by 7.3% in New

York, 4.1% in Maryland, 3.2% in Massachusetts, 2.3% in New Jersey, and 2.3% in West Virginia. In addition, 13.5% graduated from a dental school in other states or territories, and 0.5% graduated from a dental school outside of the US.

Board Certification

Table 3 lists the board certification of respondents for dental specialty. In 2021, the most common board certification was Oral and Maxillofacial Surgery (4.5%), followed by Pediatric Dentistry (3.3%), and Orthodontics (3.0%). Less than 1% of respondents were certified in Endodontics (0.9%), Prosthodontics (0.7%), Oral and Maxillofacial Pathology (0.3%), and Oral and Maxillofacial Radiology (0.2%).

Employment

Table 4 lists the current employment status of 8,896 respondents who provided this information. In 2021, 92.6% of dentist respondents were employed in dentistry for direct or indirect patient care, 2.9% retired, and the remaining 4.5% were unemployed, employed but not in dentistry, or on leave.

Table 5 shows the current employment type of 8,428 respondents who provided this information. The majority of dentists were involved in direct patient care (93.4%). Approximately 4% worked in education/academia, 1.9% worked in administration, and 0.1% worked in research.

V. Dentists Who Provided Direct Patient Care in PA, 2021 Dentist Survey

This section provides information on dentists who responded to the 2021 Pennsylvania dentist survey and provided direct patient care in Pennsylvania. In 2021, out of 8,428 dentists who reported employment information, 7,869 (93.4%) reported that they provided direct patient care.


Age and Sex

In 2021, more male than female dentists provided direct patient care in Pennsylvania and the average age was 51 years. Table 6 lists the distribution of respondents who provided direct patient care by age group and sex. For male dentists, in general, the percentage increased with age, but for female dentists, the percentage first increased with age but then decreased, with a pattern different from male dentists. Overall, more than half (52.5%) of dentist respondents who provided direct patient care were aged 50 years or older. This gender difference became larger among older age groups (Figure 4).

The distribution of race and ethnicity for dentist respondents who provided direct patient care in Pennsylvania in 2021 is listed in Table 7.



Dental Education

Figure 5 displays the states from which respondents received their dental education. In 2021, 67.1% of respondents who provided direct patient care in Pennsylvania graduated from a dental school in Pennsylvania. Approximately a quarter (23.5%) of dentists graduated from a neighboring state or a state close to Pennsylvania, including New York (7.4%), Maryland (4.1%), Massachusetts (3.3%), New Jersey (2.3%), and West Virginia (2.2%). In addition, 13.1% of dentists graduated from other states or territories and 0.5% of dentists who provided direct patient care in Pennsylvania graduated from countries outside of the US.

Board Certification

Table 8 displays the certification status of respondents who provided direct patient care in Pennsylvania in 2021. In 2021, the most common board certification was Oral and Maxillofacial Surgery (4.5%), followed by Pediatric Dentistry (3.3%), and Orthodontics (3.0%).

Specialty

Figure 6 presents the dental practice specialties of respondents who provided direct patient care. Among 7,821 dentists who responded to the specialty question, 5,757 (73.6%) reported that they practiced as a general dentist and 2,064 (26.4%) reported that they practiced as a specialist. Common specialties were orthodontics (25.2%), oral surgery (23.4%), pediatric dentistry (19.2%), endodontics (12.1%), periodontics (11.2%), prosthodontics (6.2%), anesthesiology (2.1%), and other specialties (0.7%).

Table 9 lists the number of hours that dentist respondents spent on direct patient care in Pennsylvania each week in the past 12 months in 2021. Over half of the dentists (57.8%) worked full-time or close to full-time in direct patient care. Approximately 6% of dentists worked over 40 hours per week in direct patient care. Compared to females, male dentists worked more hours per week, especially over 40 hours per week. Among general dentists, most worked 31 to 40 hours per week (55.2%), 22.1% worked 21 to 30 hours per week, 11.6% worked 11 to 20 hours per week, 6.3% worked 10 or less than 10 hours per week, and 4.8% worked over 40 hours per week.

Figure 6. Dental Specialties of Dentist Respondents Who Provided Direct Patient Care in Pennsylvania, 2021 Dentist Survey



Figure 7 displays the number of hours per week that dental specialists spent on direct patient care in the past 12 months in 2021. Approximately three quarters of dentists in the specialties of pediatric dentistry, endodontics, and prosthodontics worked more than 20 hours per week in the past 12 months. Compared to other specialties, fewer dentists in the specialties of periodontics and orthodontics worked more than 20 hours per week in the past 12 months.

Figure 7. Hours of Direct Patient Care and Specialty among Dentist Respondents in Pennsylvania, 2021 Dentist Survey





Figure 8. Dental Specialties by Sex among of Dentist Respondents Who Provided Direct Patient Care in Pennsylvania, 2021 Dentist Survey



Geography

In 2021, among dentist respondents who provided direct patient care in Pennsylvania, 6,805 reported practicing in 67 counties. Across the commonwealth, the rate of respondents who provided direct patient care in Pennsylvania was 52.4 per 100,000 population in 2021. Based upon the Center for Rural Pennsylvania's definition of rural and urban counties, Pennsylvania has 19 urban counties and 48 rural counties. In 2021, 79.8% of dentists who provided direct patient care in Pennsylvania practiced in urban counties and 20.2% practiced in rural counties. Based on the survey response data, the rate of dentists providing direct patient care was 56.5 per 100,000 population in urban counties and 40.7 per 100,000 population in rural counties. Map 1 presents the state-wide variation in these rates by county.

Figure 9 displays the distribution of practice ownership by sex among dentist respondents who provided direct patient care in Pennsylvania in 2021. Among 7,268 dentists with ownership and gender information, 3,809 fully or partially owned a private dental practice, 3,074 were employees of a dentist or a facility, and 385 worked for other institutions or organizations. In males, the percentage of dentists who fully- or partially-owned a private practice was higher than the percentage of those working for another dentist, facility or other settings. In females, the percentage of dentists who fully- or partially-owned a private practice was lowest compared to working for another dentist, facility or other settings.

Figure 9. Respondents Who Provided Direct Patient Care in Pennsylvania by Ownership and Sex, 2021 Dentist Survey





Figure 10 displays the ownership of employment by age group among dentist respondents who provided direct patient care in Pennsylvania in 2021. More dentists of older ages (45-54, 55-64, and 65+ years) owned a private dental practice than dentists at younger ages (21-34 and 35-44 years). Dentists at younger ages were more likely to be an employee of a dentist or a facility and were also more likely to work for other institutions or organizations.

Accepted Dental Coverage

Figure 11 presents a comparison of dental health insurance accepted among respondents providing direct patient care in Pennsylvania. In 2021, nearly 90% of dentists accepted private insurance. Slightly over one quarter and slightly over one third of dentists accepted Medicaid and Medicare, respectively. Slightly less than half of the dentists accepted the Children's Health Insurance Program (CHIP).




Table 12 lists the dental health insurance accepted among respondents providing direct patient care by specialty of practice in Pennsylvania. For private insurance, most general dentists (89.3%) and specialists had high acceptance rates, such as oral surgery (95.5%), pediatric dentistry (94.3%), orthodontics (93.5%), and

endodontics (90.3%). Periodontics (69.0%) and prosthodontics (43.0%) had relatively low acceptance rates for private insurance compared to other specialties.

Most anesthesiologists (77.5%) and pediatric dentists (63.0%) accepted Medicaid. Acceptance was low among oral surgeons (49.8%), orthodontists (33.1%), general dentists (23.5%), and dentists in prosthodontics (6.3%), endodontics (6.1%), and periodontics (3.1%). For Medicare, the acceptance was as follows: 64.0% in oral surgery, 41.0% in anesthesiology, 37.4% in general dentistry, 25.4% in pediatric dentistry, 11.1% in endodontics, 10.9% in prosthodontics, 9.2% in orthodontics, and 8.5% in periodontics.

For the Children's Health Insurance Program (CHIP), pediatric dentistry (72.7%), oral surgery (66.2%), and anesthesiology (57.5%) had the highest acceptance rates while periodontics (6.7%) and prosthodontics (7.1%) had the lowest acceptance rates. CHIP was accepted by 45.2% of general dentists.

New Patients

In 2021, 95.1% of dentists who provided direct patient care in Pennsylvania accepted new patients. Among general dentists, 94.1% accepted new patients. Figure 12 displays the status of accepting new patients by dental insurance coverage among dentist respondents who provided direct patient care in Pennsylvania. In 2021, almost all dentist respondents accepted new patients if they were uninsured (98.1%) or covered by private insurance (96.1%). Over half (54.7%) of respondents accepted new patients who were covered by Children's Health Insurance Program (CHIP). Most dentists did not accept new patients if they were covered by Medicaid or Medicare. Among all general dentists, 24.1% accepted new patients covered by Medicaid, 34.7% accepted new patients covered by Medicare, 45.3% accepted new patients covered by CHIP, and 91.8% accepted new patients covered by private health insurance.

Children




Figure 13. Respondents Who Provided Direct Patient Care in Pennsylvania by Age of Children Seen, 2021 Dentist Survey

Figure 13 displays the distribution of age groups for children seen by Pennsylvania dentists. In 2021, approximately 90% of dentist respondents who provided direct patient care in Pennsylvania provided care to children. A little over a quarter of the dentists see children aged five years or older (28.2%), 6.1% will see them at four years (6.1%), 23.7% will see them at three years, 16.2% will see them at two years (16.2%), 12.3% will see them at one-year-old, and 13.6% will see them at less than one-year-old.

Translation





Figure 14. Translation Services Used in the Last Year by Respondents Who Provided Direct Patient Care by Specialty in Pennsylvania, 2021 Dentist Survey

In 2021, 22.0% (1,702 out of 7,739) of respondents who provided direct patient care in Pennsylvania reported using translation services. Figure 14 displays translation services used by respondents who provided direct patient care by specialty in Pennsylvania. Dentists in the specialties of pediatric dentistry (55.5%) and oral surgery (51.5%) used more translation services and dentists in the specialties of endodontics (15.2%) and periodontics (15.2%) used less translation services. Approximately one-fifth of general dentists used translation services.

Electronic Health Records





Figure 16. Ability to Electronically Exchange Patients' Clinical Information by Respondents Who Provided Direct Patient Care by Specialty in Pennsylvania, 2021 Dentist Survey

In 2021, 58.8% (4,549 out of 7,735) of respondents who provided direct patient care in Pennsylvania reported using an electronic health records (EHR) system to collect, store and retrieve patients' clinical information. Among 5,186 dental generalists, 3,732 (72.0%) used an HER system. Figure 15 displays EHR system usage by respondents who provided direct patient care by specialty in Pennsylvania. Figure 16 displays the ability to electronically exchange patients' clinical information by respondents who provided direct patient care by specialty.

Professional Satisfaction

Figure 17 displays the degree of overall dental career satisfaction among dentist respondents who provided direct patient care in Pennsylvania. In 2021, 95.9% of dentist respondents who provided direct patient care were either satisfied or very satisfied with their dental careers. Among general dentists, 95.3% were either satisfied or very satisfied with their dental careers.

Figure 17. Respondents Who Provided Direct Patient Care in Pennsylvania by Overall Dental Career Satisfaction, 2021 Dentist Survey







Length of Practice

Table 15 presents the length of time during which respondents who provided direct patient care in Pennsylvania practiced dentistry. Among these dentists, approximately 50% had practiced 16 years or longer. The other 50% of dentists practiced at various lengths ranging from less than three years to less than 16 years.


With regards to the anticipated length of time in practice, over one third of dentists reported 16 years or longer (33.3%) in future practice, followed by 19.5% for six to ten years of practice. The other 47.2% of dentists anticipated various length of practice, including 16.3% for less than three years, 17.6% for three to five years, and 13.4% for 11 to 15 years (Table 16).


Figure 20 displays the primary reasons for leaving direct patient care in Pennsylvania in less than 6 years among dentist respondents who provided direct patient care in Pennsylvania in 2021. Close to two thirds of dentists indicated that retirement (62.2%) was the primary reason for leaving direct patient care in Pennsylvania in less than 6 years.

For dentist respondents aged 55 years or older, retirement was the primary reason for leaving direct patient care in less than six years (96.0% among those aged 65 years or older; 85.6% among those aged 55 to 64 years). Figure 21 displays the primary reasons for leaving direct patient care in Pennsylvania in less than six years by age group among dentist respondents less than 55 years of age. For younger dentists aged 21 to 34 years and 35 to 44 years, family reason was the primary reason for leaving direct patient care in less than six years (43.8% for those aged 21 to 34 years and 24.9% for those aged 35 to 44 years). Completing further training was also a main reason for leaving direct patient care in less than six years for dentists aged 21 to 34 years, and physical demand was another main reason for dentists aged 35 to 44 years. For dentists aged 45 to 54 years, retirement (41.2%) and physical demand (23.8%) were two main reasons for leaving direct patient care in less than six years.

VI. All Dental Hygienists Licensed in PA, 2021 Dental Hygienist Survey

This section provides information on all the dental hygienists who responded to the 2021 Pennsylvania dental hygienist relicensing survey. A total of 8,812 dental hygienists renewed their licenses in 2021 and responded to the survey.

Age and Sex

In 2021, the average age of dental hygienist respondents was 46 years. Table 17 lists the distribution of dental hygienist respondents by age group and sex in 2021. Majority of dental hygienist respondents were females (98.8%) and there were only 107 (1.2%) male dental hygienist respondents in Pennsylvania in 2021. For female dental hygienist respondents, the age distribution was generally equivalent across all age groups except for the age group of 65 years or older.

Race and Ethnicity

Table 18 displays the distribution of race and ethnicity among dental hygienist respondents in 2021. Majority of dental hygienists were non-Hispanic Whites (93.5%) and the other races each comprised of 2% or less among the dental hygienists in 2021.

Residence

Figure 22 displays the state of residence among dental hygienist respondents in 2021. The majority of dental hygienist respondents resided in Pennsylvania (89.0%). A small number of dental hygienists lived in neighboring or nearby states, including New Jersey (2.7%) and Ohio (1.4%). Approximately 6.9% of dental hygienists lived in the other 47 states or territories in the US and less than 0.1% lived outside of the US.

Dental Hygiene Education




Figure 23. Respondents Licensed in Pennsylvania by State of Graduation from Dental Hygiene School, 2021 Dental Hygienist Survey

Figure 23 displays the states in which respondents graduated from dental hygiene school. The majority of dental hygienist respondents reported that they graduated from a dental hygiene school in Pennsylvania (77.5%). Nearly 20% of dental hygienist respondents reported that they graduated from a dental hygiene school in a neighboring or nearby state, including West Virginia (5.8%), Maryland (4.4%), New York (3.1%), New Jersey (2.6%), and Ohio (2.4%). Approximately 4.3% of dental hygienists reported that they graduated from a dental hygiene school in other states or territories. Only 0.04% of dental hygienists graduated from a dental hygiene school outside of the US.

Figure 22. Respondents Licensed in Pennsylvania by State of Residence, 2021 Dental Hygienist Survey



Dental Hygiene Certification

Through additional training, dental hygienists can become certified to perform advanced duties with or without direct supervision. Dental hygienist respondents reported certification of an expanded function dental assistant certificate or Pennsylvania dental hygiene local anesthesia permit. Respondents could select more than one type of certification. Table 21 displays the number of respondents who held dental hygiene certifications.

Public Health Dental Hygiene Practitioners

Public health dental hygiene practitioners (PHDHPs) were first certified in Pennsylvania in January 2010. PHDHPs were created to increase access to dental services for individuals living in Health Professional Shortage Areas (HPSAs) by allowing these dental hygienists to perform educational, preventive, therapeutic,

intra-oral and radiologic procedures without supervision of a dentist at identified public health practice sites. PHDHPs are required to refer patients to a dentist annually. Identified practice sites include schools; correctional facilities; health care facilities such as hospitals; personal care homes; domiciliary care facilities; older adult daily living centers; federally qualified health centers (FQHCs); childcare centers; medical offices in dental shortage areas; and public or private institutions under the jurisdiction of a federal, state or local agency. In 2021, 938 (11.0%) of dental hygienist respondents reported that they were certified as PHDHPs in Pennsylvania and 278 (29.6%) reported performing as a PHDHP in their primary job.

Employment

Table 22 displays the employment status of dental hygienist respondents in 2021.

Among respondents employed in dental hygiene, approximately 95% provided one or more hours per week in direct patient care. Most dental hygienists (80.2%) spent over 20 hours per week in direct patient care. In addition, among 326 dental hygienist respondents who were not in direct patient care and responded to the question of planning to return to direct patient care in the next five years, 169 (51.8%) answered "Yes, I plan to return to direct patient care in the next five years".

VII. Dental Hygienists Providing Direct Patient Care in PA, 2021 Dental Hygienist Survey

This section provides information on dental hygienists who responded to the 2021 Pennsylvania dental hygienist relicensing survey and provided direct patient care in Pennsylvania. Respondents who provided direct patient care in Pennsylvania are defined as those respondents who reported employment in dental hygiene and provided at least one hour of direct patient care in Pennsylvania per week during the prior year. In 2021, 7,169 dental hygienist respondents indicated that they provided direct patient care.

Age and Sex

In 2021, the average age of dental hygienist respondents who provided direct patient care was 45 years. Table 25 lists the distribution of respondents who provided direct patient care in Pennsylvania across age groups for 2021. Except for the group of 65 years of age or older, the distribution of dental hygienist respondents across each age group is generally equivalent.

Race and Ethnicity

The distribution of dental hygienist respondents who provided direct patient care in Pennsylvania by race and ethnicity, in 2021, is listed in Table 26. Majority of dental hygienist respondents who provided direct patient care were non-Hispanic whites (93.5%). Each of the other racial groups comprised of 2% or less of dental hygienist respondents, including Hispanics (2.1%), non-Hispanic Asians (1.9%), and non-Hispanic Blacks (1.6%).

Dental Hygiene Education

Figure 24 displays the states in which respondents who provided direct patient care in Pennsylvania graduated from dental hygiene schools. Majority of respondents (77.7%) who provided direct patient care in Pennsylvania graduated from schools in Pennsylvania and less than 0.1% graduated from dental hygiene schools outside of the US. Some dental hygienists graduated from dental hygiene schools in neighboring or

nearby states, including West Virginia (5.7%), Maryland (4.6%), New York (3.0%), Ohio (2.5%), and New Jersey (2.4%).

Figure 24. Respondents Providing Direct Patient Care by State of Graduation, 2021 Dental Hygienist Survey





Dental Hygiene Certification

Table 30 lists the number of respondents who provided direct patient care in Pennsylvania by the type of dental hygiene certification(s) they held. Respondents may possess multiple certificates. Through additional training, dental hygienists can become certified to perform advanced duties with or without direct supervision. Respondents reported certification of an expanded function dental assistant certificate or Pennsylvania dental hygiene local anesthesia permit. Respondents could select more than one type of certification. In 2021, 2.8% of dental hygienist respondents held an expanded function dental assistant permit and 47.3% held a dental hygiene local anesthesia permit.

Table 31 displays expanded function dental assistants by age group. In 2021, 1,461 respondents worked as expanded functional dental assistants in their primary duties. The percentage was higher in the youngest age group (33.3%). In the other age groups, the percentages were comparable and were around 20% except in those aged 65 years or older.

Public Health Dental Hygiene Practitioners (PHDHP)

PHDHPs were created as a specific job title to increase access to dental services for individuals living in Health Professional Shortage Areas (HPSAs) by allowing these dental hygienists to perform educational, preventive, therapeutic, intra-oral and radiologic procedures without the supervision of a dentist at identified public health practice sites. PHDHPs are required to refer patients to a dentist annually. PHDHPs were first certified in Pennsylvania in January of 2010. In 2021, 694 out of 6,967 (10.0%) respondents who provided direct patient care in Pennsylvania were certified as PHDHPs. Of these 694 respondents, only 217 (31.3%) reported performing as a PHDHP in their primary job (Table 34). In addition, 7.6% of respondents who provided direct patient care in Pennsylvania intended to apply for a PHDHP certification in 2021 (Table 35).




Figure 26. Respondents by the Number of Hours Spenton Providing Direct Patient Care in Pennsylvania and Age Group, 2021 Dental Hygienist Survey



Geography

In 2021, 7,169 dental hygienist respondents provided direct patient care in Pennsylvania. The rate of respondents who provided direct patient care in Pennsylvania was 55.2 per 100,000 population. Among respondents who provided county information in the survey, 1,576 were employed in the rural counties and 4,922 were employed in the urban counties. The rate was 46.6 per 100,000 population (range: 13.8 to 81.7 per 100,000) in the rural counties, compared to 51.2 per 100,000 population in urban counties (range: 23.5 to 74.1 per 100,000). Please note: the average rates in the rural counties and urban counties were lower than the average rate in the state because county information was missing in some respondents. Map 2 shows the wide variation in rates of respondents who provided direct patient care in Pennsylvania per 100,000 population, from the lowest of 14.4 per 100,0000 in Forest County to the highest of 80.6 per 100,000 in Warren County.

Employment













Of dental hygienists who provided direct patient care in Pennsylvania, 3,048 responded to the question of planning to leave direct patient care in less than six years. The primary reason for leaving was retirement (42.0%), followed by physical demands (16.2%), stress/burnout (14.5%), change careers (10.2%), family reasons (8.0%), completing further training (4.7%), financial reasons (2.7%), and relocation (1.3%) (Table 44).

Figure 32 displays the reasons why respondents who provided direct patient care in Pennsylvania planned to leave in less than six years by age group. Because retirement was the primary reason for leaving direct patient care in less than six years for those aged 65 years or older and for those aged 55 to 64 years, the figure excluded these two age groups. As shown, physical demand, stress or burnout is the primary reason for dental hygienists to leave direct patient care in less than six years for younger dental hygienists less than 45 years of age. In addition, dental hygienists aged 18 to 34 years were more likely to leave direct patient care in less than six years for family reasons. For dental hygienists aged 35 to 44 years, career changes were another reason to leave and for dental hygienists aged 45 to 54 years, retirement was the primary reason to leave.
