# SUICIDE DEATHS IN DELAWARE COUNTY, PENNSYLVANIA, 2020


# **BACKGROUND**

Delaware County, Pennsylvania is an urban county with a population of 576,000 people (279,000 males and 297,000 females). In 2020, Delaware County had 72 suicide deaths (55 males and 17 females) which occurred at a rate of 12.5 suicide deaths per 100,000 people. The Pennsylvania Violent Death Reporting System (PAVDRS) worked closely with the Bureau of Health Statistics and Registries, the Delaware County Office of the Medical Examiner, and Delaware County law enforcement to gather detailed information about each violent death. Below are some results of those collaborations.


## In 2020, more than 1 suicide death occurred each week in Delaware County.

#### **Characteristics of Suicide Victims**


#### Sex of Victims:



- In Delaware County, males were almost 3 times more likely to die by suicide than females.
- Overall, age-adjusted suicide rates in Delaware County were lower than the state average:
  - **Delaware County Rates**: 12.0 deaths per 100,000 residents (males 19.2 and females 5.7).
  - Pennsylvania Rates: 12.6 deaths per 100,000 residents (males 20.4 and females 5.0).




### Characteristics of Suicide Victims by Race/Ethnicity and Sex:





#### **Most Common Precipitating Circumstances:**



Notes: The denominator for Most Common Precipitating Circumstances is the sum of records with coroner/medical examiner and law enforcement circumstantial information about the violent death. Percentages may not add up to 100% due to rounding.

The PAVDRS program is a state level surveillance system funded and overseen by the Centers for Disease Control and Prevention (CDC). It is part of the larger National Violent Death Reporting System (NVDRS). The PAVDRS program collects data on suicides, homicides, deaths of undetermined intent, and accidental firearm deaths. The program is required to collect data directly from death certificates, coroners/medical examiners, and law enforcement. These sources contribute to a comprehensive understanding of each violent death. PAVDRS/NVDRS data is used for research, policymaking, and, ultimately, to develop violence prevention programs and strategies that will enhance community safety.
