SUICIDE DEATHS IN YORK COUNTY, PENNSYLVANIA, 2020


BACKGROUND

York County, Pennsylvania is an urban county with a population of 456,000 people (227,000 males and 229,000 females). In 2020, York County had 59 suicide deaths (43 males and 16 females) which occurred at a rate of 12.9 suicide deaths per 100,000 people. The Pennsylvania Violent Death Reporting System (PAVDRS) worked closely with the Bureau of Health Statistics and Registries, the York County Coroner's Office, and York County law enforcement to gather detailed information about each violent death. Below are some results of those collaborations.


In 2020, York County averaged more than 1 suicide death every week.


Characteristics of Suicide Victims

Sex of Victims:




- In York County, males were almost 3 times more likely to die by suicide than females.
- Overall, age-adjusted suicide rates in York County were higher than the state average:
 - York County Rates: 16.7 100,000 deaths per residents (males 26.1 and females 7.5).
 - Pennsylvania Rates: 12.6 deaths per 100,000 residents (males 20.4 and females 5.0).





70-79 Years 80+ Years


Characteristics of Suicide Victims by Race/Ethnicity and Sex:





Notes: The denominator for Most Common Precipitating Circumstances is the sum of records with coroner/medical examiner and law enforcement circumstantial information about the violent death. Percentages may not add up to 100% due to rounding.

The PAVDRS program is a state level surveillance system funded and overseen by the Centers for Disease Control and Prevention (CDC). It is part of the larger National Violent Death Reporting System (NVDRS). The PAVDRS program collects data on suicides, homicides, deaths of undetermined intent, and accidental firearm deaths. The program is required to collect data directly from death certificates, coroners/medical examiners, and law enforcement. These sources contribute to a comprehensive understanding of each violent death. PAVDRS/NVDRS data is used for research, policymaking, and, ultimately, to develop violence prevention programs and strategies that will enhance community safety.
