


Pennsylvania Cancer Control Prevention and Research Advisory Board December 2, 2015



Special Cancer Institute Initiatives

University of Pennsylvania \$150,000

- Seven Cancer awareness conferences with 1,979 participants
- Survivorship Conference for Young Adult Cancer Survivors with 424 attendees

Pennsylvania State University \$150,000

- Hosted 13 Community Education Classes facilitated by Community Health Workers (CHW)with 466 attendees
- Six CHW-facilitated National Cancer Survivors Day program with 558 attendees

Northeast Regional Cancer Institute \$150,000

- Held 20 Community and Health System resource days with 8,325 participants
- 40 cancer awareness events in Northeast Pa. with 1,168 participants
- A total of **681 breast**, **cervical**, **and colon cancer screenings** were performed for low income, uninsured and underinsured residents of Northeast Pa.
- 16 Professional Education programs were conducted with **374 participants**

University of Pittsburgh \$150,000

- 13 Community Screening Events serving 359 individuals with 63 of those getting screened
- 15 Community Prevention & Risk Reduction Events with 3,604 participants
- A total of 11,712 students reached through Healthy Choices for Students program
- A total of 4,605 participants for the *Healthy Choices for Students* summer program

Cancer Survivorship

Pennsylvania Breast Cancer Coalition's survivorship outreach "67 Women-67 Counties: Facing Breast Cancer in Pennsylvania" reached approximately 5,400 people from July 2014-June 2015.

Breast and Cervical Cancer Screenings

The HealthyWoman Program provided breast and cervical cancer screening and diagnostic services to eligible women, ages 40 to 64. The number of women served from all funding sources was 9,856.

A total of 224 women were referred for cancer treatment in Pennsylvania.


• Designed The Burden of Cancer in Pennsylvania report
