Key Updates

Recap of Board Approvals in the 4th RHRCA Public Session

- Mr. Zegiestowsky highlighted that two Board actions were unanimously approved at the September meeting based on terms outlined in the Interagency Agreement, including:
 - Delegation of Duties (i.e., Delegation of Duties from DOH to RHRCA)
 - Delegation of Authority to Executive Director (i.e., Delegation from RHRCA Board to Executive Director)

- RHRCA Organization Formation Update- Mr. Zegiestowsky informed of the progress of the RHRCA organization formation.
 - An Employer Identification Number (EIN) for the Authority was obtained in July 13, 2020 from the IRS
 - o The .gov domain was obtained on September 8, 2020
 - DOH completed submission of CMMI continuation application for Performance Year 3 on Friday, September 11, 2020
 - The process to build out the RHRCA organization to meet requirements for approval as an organization by CMMI continues
 - Target completion of this for submission of RHRCA application to CMMI is being reevaluated
