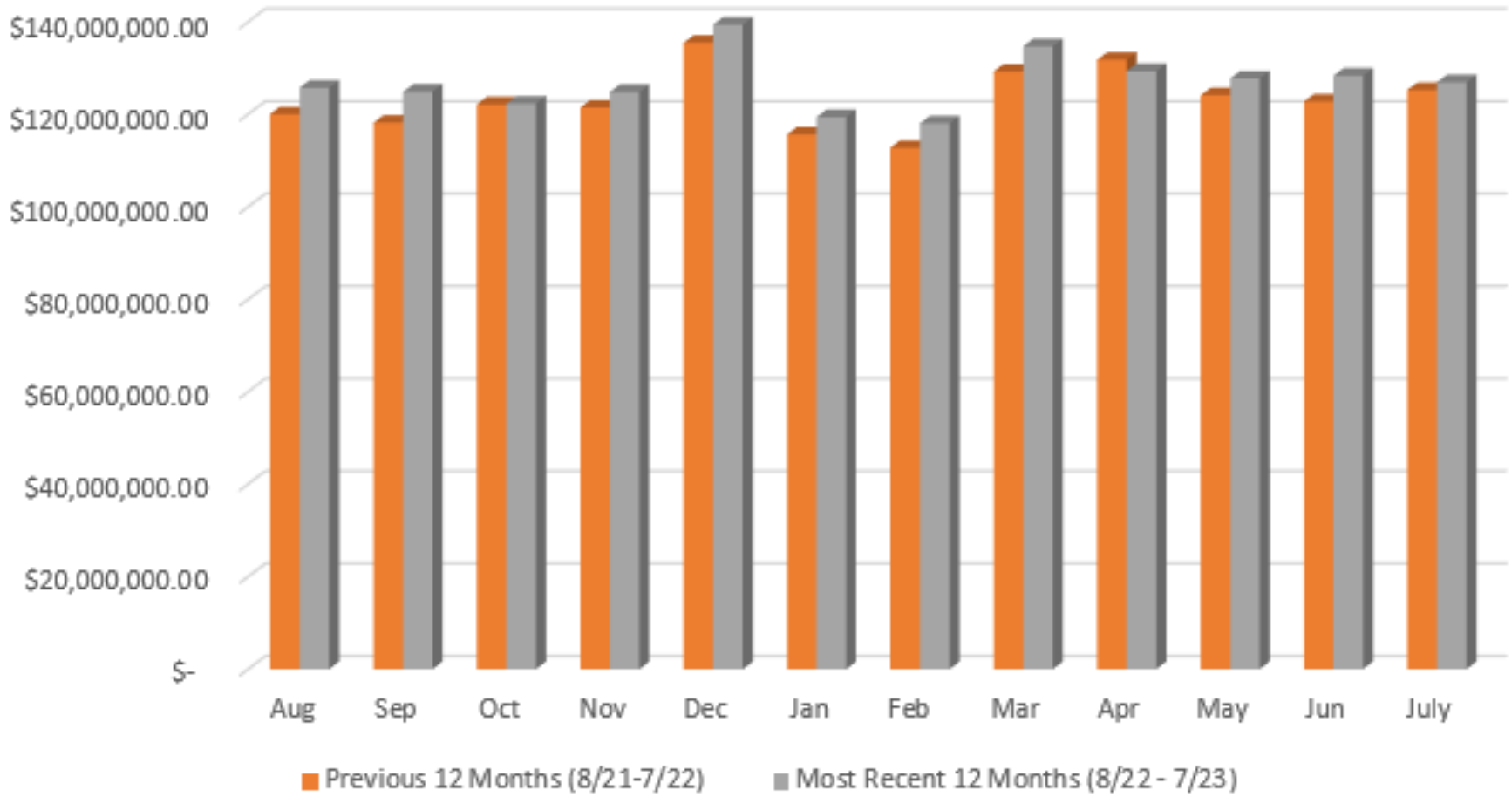
Medical Marijuana Program Update

- 942,231 Patients and Caregivers Registered;
- 430,293 Active Patient Certifications;
- 1,867 Approved Practitioners;
- 34.4 Million Patient Dispensing Events;
- 97.8 Million Products Dispensed;
- \$8 Billion in Total Sales:
 - \$4.9 Billion by Dispensaries
 - \$3.1 Billion by G/Ps to Dispensaries
- 178 Operational Dispensaries

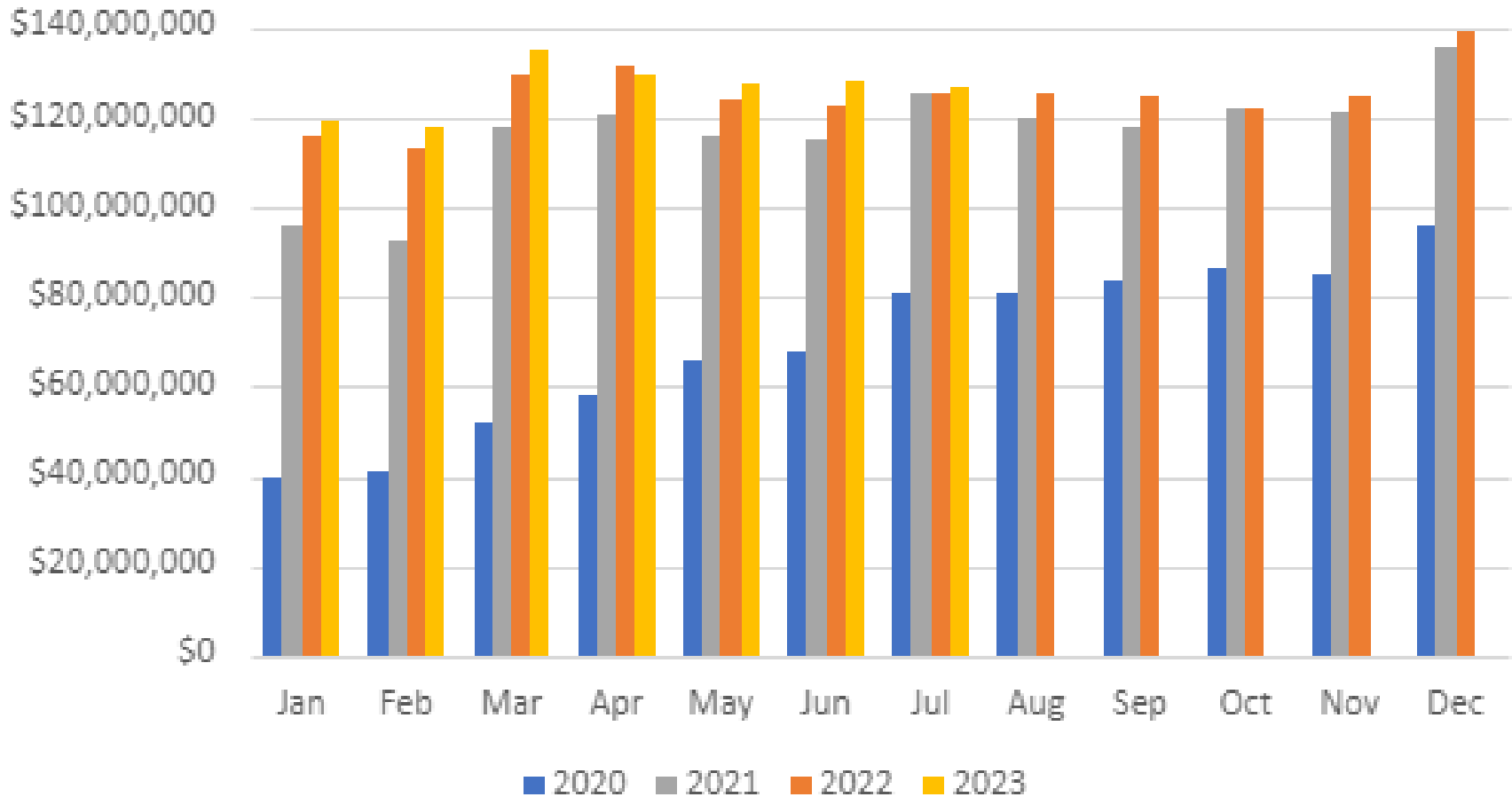

Month on Month Dispensary Sales



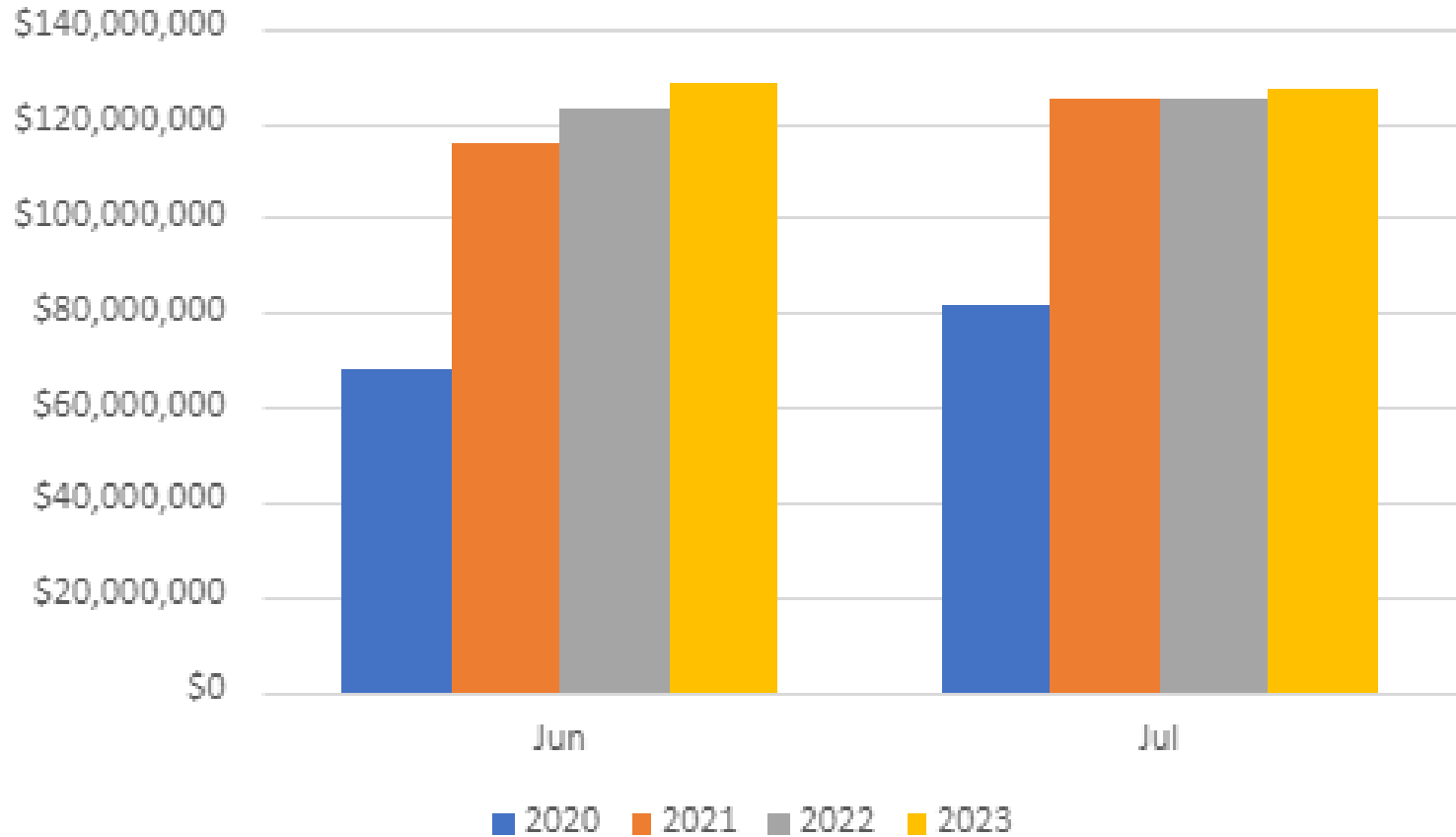

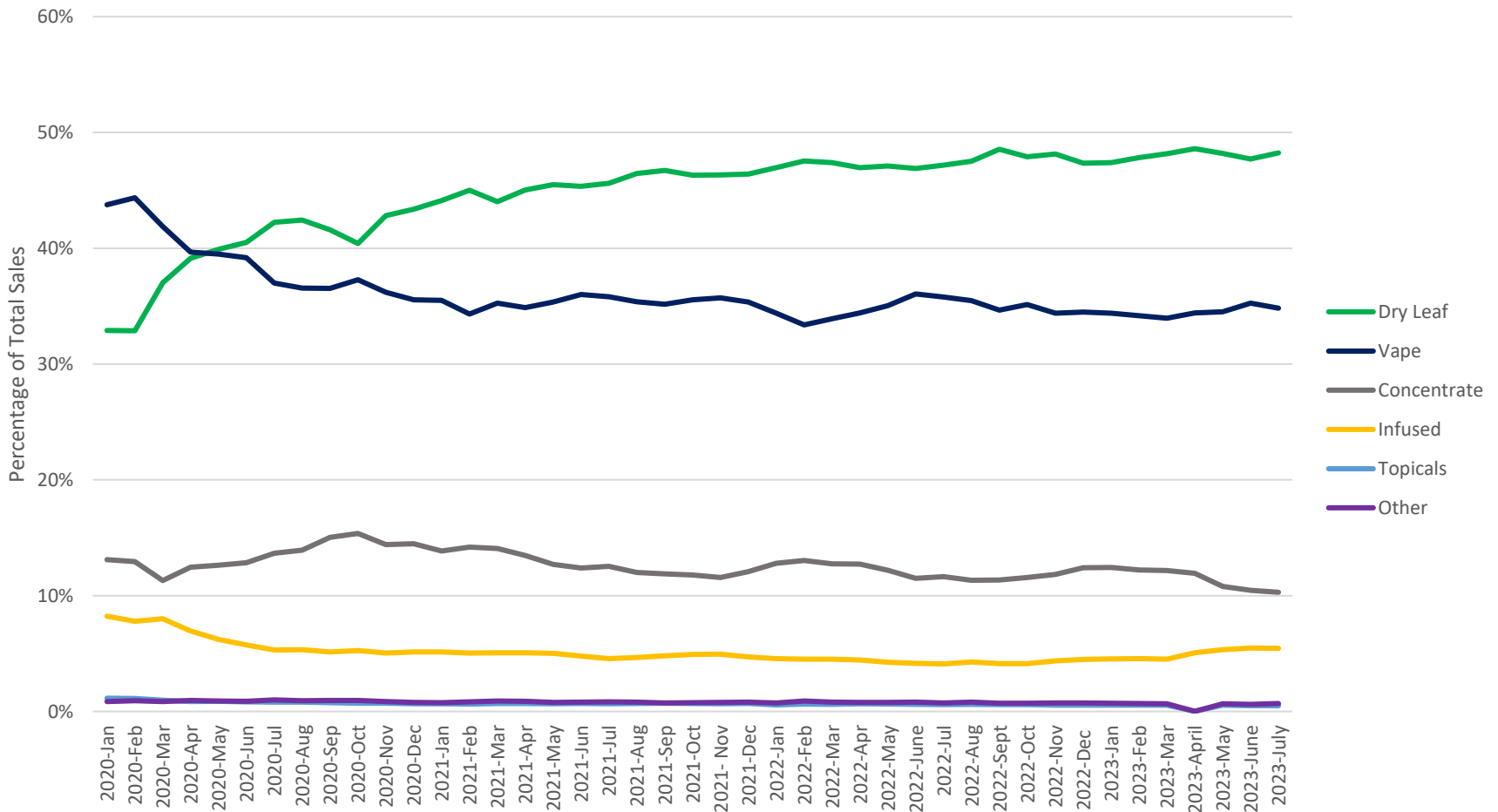
Year on Year Dispensary Sales for June and July



Program Metrics: Permittee Pricing Trends

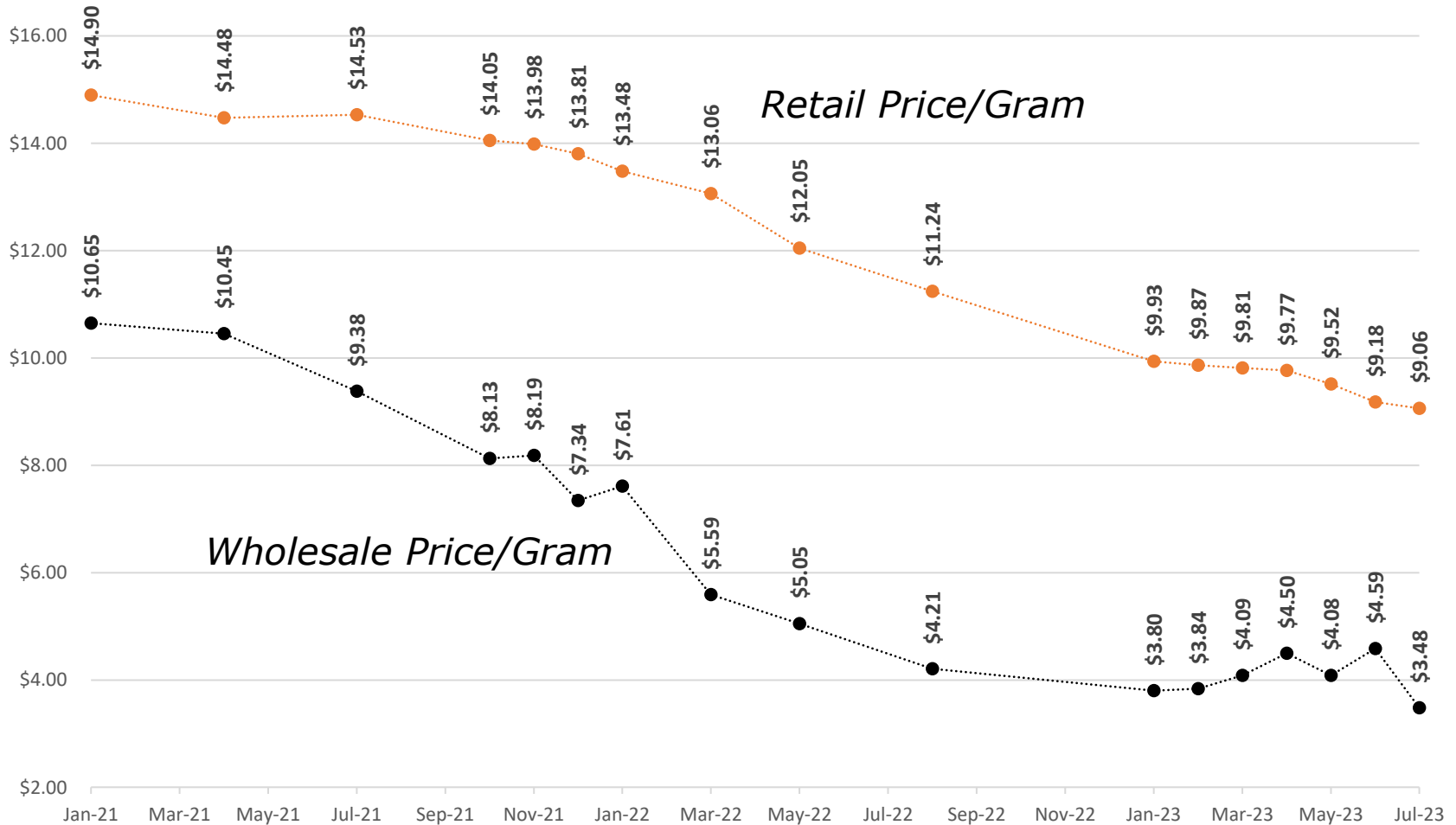
