

Viewing Facility Users: Active and Terminated

After logging into EDRS as a Facility Account Manager, click on the Users (figure 1) button of the home screen or select Security>Users (figure 2) from the Table Maintenance Drop Down on the top tool bar.

Enter either the full facility name or a part of the facility name (figure 1) and click the **Search All** (Figure 2) button to view all active and terminated users associated with your facility.



The search results display all currently active data providers and non-data providers associated with your facility. The total number (figure 1) of users will display at the bottom on each page of the search results, but only 15 user account records display on each page of the search results.
